STATEMENT

By Decision No. R87-833-I issued June 18, 1987, hearing in the above captioned matter was set for July 29, 1987, at 9:00 a.m. in the Commission Hearing Room, Office Level Two (OL 2), Logan Tower, 1580 Logan Street, Denver, Colorado 80203. Hearing was called as scheduled and counsel for parties present requested that this matter be continued to allow additional opportunity for negotiation and settlement by Public Service Company of Colorado and the City of Aurora. This request was granted and this matter should proceed pursuant to the following Order.

O R D E R

THE EXAMINER ORDERS THAT:

1. On or before September 21, 1987, Public Service Company of Colorado shall file with the Commission and serve on all parties to this proceeding a final progress report which sets forth details of refunds made by Public Service Company of Colorado pursuant to the Refund Plan submitted by Public Service Company on December 10, 1986, subject to conditions set forth in the Stipulation filed with the Commission on February 17, 1987.

2. On or before September 21, 1987, Public Service Company of Colorado, shall file with the Commission and serve on all parties to this proceeding a final status report regarding results of negotiations with the City of Aurora.

3. On or before October 10, 1987 any party intending to request additional hearing in this matter shall file with the Commission and serve on all parties to this proceeding a motion that additional hearing be set.

4. In the event any such motion for hearing is filed or issues remain for resolution in this proceeding, a prehearing conference will be held as follows:
