(b.) District Customers - Durango West Metropolitan Districts 1 and Durango West Metropolitan District 2 and La Plata Vista HOA.(or other customers who receive or in the future may receive water in bulk or wholesale arrangements.)

(b.1) Bulk Sales Customers - Durango West Metropolitan District No. 1. Monthly charge for water service to Durango West Metropolitan District No. 1 is to be a \$5.50 Monthly Meter Charge and Water Charges to be paid for at the rate of \$2.90 per 1,000 gallons.

(b.2) Bulk Sales Customers - Durango West Metropolitan District No.2. Monthly charge for water service to Durango West Metropolitan District No.2 is to be a \$5.50 Monthly Meter Charge and Water Charges to be paid for at the rate of \$2.90 per 1,000 gallons.

(b.3) Bulk Sales Customer - La Plata Vista HOA. Monthly charge for water service to La Plata Vista HOA is to be a \$5.50 Monthly Meter Charge and Water Charges to be paid for at the rate of \$2.90 per 1,000 gallons.

(c.) Water Curtailment Plan .

STAGE 1:

Outside watering limited to 2 (two) days/week. Tuesday and Friday 7am to 9am and 7pm to 9pm. Hoses may be used but not left unattended without sprinkler head or control device (no open running hoses unattended). No car/boat/recreation vehicle/etc. washing. No filling of tanks, ponds, etc. (except for livestock). No swimming pools, koy ponds, waterfalls or any types of landscaping ponds may be filled. No excess water running down roads/ditches/driveways, etc. Watering potted plants with pails/buckets/water cans is allowed at anytime.

***STAGE 2: Effective April 22, 2003 upon approval of this Application by the Commission.**

Water limited to 1(one) day/week. All other restrictions of Stage 1 apply.

***STAGE 3: Effective upon Application to and Approval by Commission**

No outside watering. All other restrictions of Stage 1 apply.

***STAGE 4: Effective upon Application to and Approval by Commission**
Limits on gallons per month per household will be implemented with fines for non-compliance. All other restrictions of Stage 1 apply.

To be effective upon approval by the Commission.

3. A staff member of Lake Durango Water Company will supervise control by periodic checking outside watering. Lake levels will determine what stage will be implemented.

4. Penalties for non-compliance of the water curtailment are as follows:

1st. Offense - Written warning

2nd. Offense - \$50.00

3rd. Offense \$75.00

4th. Offense \$ 100.00

(These fines will be attached to the customer's water bill.)

5. Notification to the customer of water curtailment plan will be published in the local newspaper.
