# STIPULATED MOTION FOR IMPOSITION OF RESTRICTIVE AMENDMENT AND CONDITIONAL WITHDRAWAL OF INTERVENTION OF METRO TAXI, INC. IN DOCKET NO. 03A-020BP

Metro Taxi, Inc., (Metro Taxi or Intervenor), by and through its attorney, Charles M. Williams, of Charles M. Williams, P.C., and Care-4-U Transportation, Inc. (Care-4-U or Applicant), by and through attorney, Charles J. Kimball of Kimball & Nespor, P.C., file the above stipulated motion with the Colorado Public Utilities Commission (Commission or PUC). In support thereof the parties state as follows:

I. Applicant seeks the following authority in its permanent authority application:

For authority to extend operations under Item (I) of Contract Carrier Permit No. B-9835 to include the transportation of passengers and their baggage, between all points within the Counties of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, and Jefferson, State of Colorado; and to eliminate restriction (4) which currently reads as follows: Item (I) is restricted to the use of a maximum of four vehicles. This portion

of the application is restricted to providing transportation service for Arapahoe County Community Services, 2009 West Littleton Boulevard, Littleton, Colorado 80120. The extended permit will read as follows: Item (I). Transportation of passengers and their baggage between all points in the Counties of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, and Jefferson. Item (II). Transportation of passengers and their baggage between all points in the Counties of Adams, Arapahoe, Boulder, Denver, Douglas, and Jefferson, State of Colorado.

RESTRICTIONS: Item (I) is restricted: (1) to providing transportation services for Arapahoe County Community Services Department, 2009 West Littleton Boulevard, Littleton, Colorado 80120; (2) to providing transportation to passengers who are recipients of Medicaid; and (3) against providing any transportation originating or terminating at Denver International Airport, Denver, Colorado. Item II is restricted to (1) providing transportation service for the City and County of Denver Department of Human Services; (2) Douglas County Department of Human Services; and (3) against the transportation of passengers 17 years of age and younger.

This matter is set for hearing before the Commission on March 24, 2003.

A copy of the PUC Notice of the Application is attached hereto as Exhibit 1. A copy of the existing permit in B-9835 of Care-4-U is attached hereto at Exhibit 2. By the application, Care-4-U seeks only to eliminate the number of vehicles restriction in Part I of its existing permit.

- II. Intervenor opposes this application, alleging a material interest in said proceeding.
- III. Applicant has reviewed its application, the needs of its supporting witnesses, the services it proposed to render under the authority sought in said application, and the intervention of Metro Taxi. Applicant now finds that by restricting its application as set forth herein, Applicant can eliminate the interests of Intervenor without impairing its ability to perform the services envisioned by this application. Accordingly, Applicant hereby moves to restrictively amend its application to further restrict it to the use of a maximum of ten (10) vehicles, six of which must

not be sedans. If the amendment is accepted by the Commission, the authority sought in this application would be redefined as follows:

- I. Transportation of passengers and their baggage, between all points in the Counties of Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, and Jefferson, State of Colorado.
- II. Transportation of passengers and their baggage, between all points in the Counties of Adams, Arapahoe, Boulder, Denver, Douglas, and Jefferson, State of Colorado.

RESTRICTIONS: This permit is restricted as follows:

- (1) Item I is restricted to providing transportation services for Arapahoe County Community Services Department, 2009 West Littleton Boulevard, Littleton, Colorado 80120;
- (2) Item I is restricted to providing transportation to passengers who are recipients of Medicaid;
- (3) Item I is restricted against providing any transportation originating or terminating at Denver International Airport, Denver, Colorado;
- (4) Item I is restricted to the use of a maximum of ten vehicles, six of which must not be sedans;
- (5) Item II is restricted to providing transportation service for:
- A. The City and County of Denver Department of Human Services;
- B. Douglas County Department of Human Services; and
- C. Restricted against the transportation of passengers 17 years of age and younger.

The parties believe that the proposed amendment is restrictive in nature, and does not require renotice.

IV. Applicant and Intervenor respectively and respectfully urge the Commission's acceptance of the restrictive amendment set forth in Paragraph III above. Acceptance of this restrictive

amendment would eliminate the interests of Metro Taxi and eliminate its need to expend

additional resources in pursuit of its intervention in this proceeding. Eliminating the interests of Intervenor would lessen time spent at hearing. Conservation of resources in such matters are in the public's best interest.

V. Upon the Commission's finding the restrictive amendment set forth in Paragraph III above to be administratively acceptable, and accepting it in the form submitted, Metro Taxi's intervention can be deemed withdrawn. In the event the offered restrictive amendment is not accepted, or is accepted in a form other than as submitted, Metro Taxi specifically does not withdraw its intervention and gives notice to its intent to continue its opposition to the application.
