PARTIAL SUSPENSION OF OPERATIONS**

I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On November 7, 2003, Ramblin' Express Inc., doing business as Rocky Mountain Limousine, Inc. (Rocky Mountain Limousine), filed an application seeking authority to suspend operations under the portion of Certificate of Public Convenience and Necessity (CPCN) PUC No. 47966 which authorizes scheduled and call-and-demand limousine service, between points in the area comprised of the Counties of Pueblo, El Paso, and Douglas, State of Colorado, on the one hand, and the Cities of Blackhawk and Central City, Colorado, on the other hand.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on November 17, 2003. The Commission set this matter for hearing on January 19, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension of a portion of CPCN PUC No. 47966.

II. ORDER

A. The Commission Orders That:

1. The hearing set for January 19, 2004, is vacated.
2. This application was deemed complete on January 7, 2004, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed by Rocky Mountain Limousine for authority to suspend operations under the portion of Certificate of Public Convenience and Necessity PUC No. 47966 which authorizes scheduled and call-and-demand limousine service, between points in the area comprised of the Counties of Pueblo, El Paso, and Douglas, State of Colorado, on the one hand, and the Cities of Blackhawk and Central City, Colorado, on the other hand, is granted.
4. The suspension of motor vehicle operations under the above-described portion of Certificate of Public Convenience and Necessity PUC No. 47966 is authorized from December 7, 2003, through June 7, 2004.
5. On or before May 4, 2004, Rocky Mountain Limousine shall file a written request either to reinstate the suspended portion of Certificate of Public Convenience and Necessity PUC No. 47966 or to extend the suspension period.

6. The failure to file a written request either to reinstate the suspended portion of Certificate of Public Convenience and Necessity PUC No. 47966 or to extend the suspension period on or before May 4, 2004, may result in revocation of the suspended portion of the certificate without further notice.

7. This Order is effective immediately on its Mailed Date.
