#### A. Statement, Findings and Conclusions

1. On November 10, 2003, Estes Park Express, Ltd., (Estes Park Express) filed an application seeking authority to temporarily suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 54696.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on November 17, 2003. The Commission set this matter for hearing on January 21, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension.
