# I. <u>BY THE COMMISSION:</u>

# A. Statement, Findings and Conclusions

- 1. On December 11, 2003, T F Transportation, LLC, with Mark Fefer as manager, filed an application for approval to transfer Contract Carrier Permit No. B-9824 to T F Transportation, LLC, with Samvel Tatevosyan as manager.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 15, 2003. The Commission set this matter for hearing on February 17, 2004.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted with this application warrants granting the requested transfer.

- 5. The financial standing of T F Transportation, LLC, with Samvel Tatevosyan as manager, has been satisfactorily established.
- 6. T F Transportation, LLC, with Samvel Tatesyan as manager, is ready, willing, and able to properly perform the service as requested.
- 7. This application for permanent approval of the transfer of Contract Carrier Permit No. B-9824 is in the public interest.

# II. ORDER

## **A.** The Commission Orders That:

- 1. The hearing set for February 17, 2004, is vacated.
- 2. This application was deemed complete on January 21, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by T F Transportation, LLC, with Mark Fefer as manager, for approval to transfer Contract Carrier Permit No. B-9824, subject to encumbrances, if any, against the authority, to T F Transportation, LLC, with Samvel Tatevosyan as manager, is granted.
- 4. T F Transportation, LLC, with Samvel Tatevosyan as manager, shall operate in accordance with all applicable Commission rules and regulations.
- 5. Approval of the transfer of Contract Carrier Permit No. B-9824 is conditioned on the prior filing by T F Transportation, LLC, with Mark Fefer as manager, of delinquent reports, if any, covering operations under the permit up to the consummation of the transfer.

- 6. TF Transportation, LLC, with Samvel Tatevosyan as manager, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. TF Transportation, LLC, with Samvel Tatevosyan as manager, shall also adopt the tariff of TF Transportation, LLC, with Mark Fefer as manager, which shall become that of TF Transportation, LLC, with Samvel Tatevosyan as manager, until changed in accordance with the public utilities law. TF Transportation, LLC, with Samvel Tatevosyan as manager, shall pay the appropriate vehicle identification fee. TF Transportation, LLC, with Mark Fefer as manager, shall file a terminating annual report from the first of January to the date of this Order. An acceptance of transfer signed by both TF Transportation, LLC, with Mark Fefer as manager, and TF Transportation, LLC, with Samvel Tatevosyan as manager, shall be filed with the Commission. TF Transportation, LLC, with Samvel Tatevosyan as manager, may not begin operations until these requirements have been met and it has received notice in writing from the Commission that it is in compliance and may begin service.
- 7. If T F Transportation, LLC, with Mark Fefer as manager, and TF Transportation, LLC, with Samvel Tatevosyan as manager, do not comply with the requirements of this Order within 60 days of its effective date, then the approval to transfer Contract Carrier Permit No. B-9824 shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

8. This Order is effective immediately on its Mailed Date.
