I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On December 16, 2003, Colorado Mountain Tours, Inc. (Colorado Mountain

Tours) filed an application seeking authority to suspend operations under Certificate of Public

Convenience and Necessity (CPCN) PUC No. 55669.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on December 29, 2003. The Commission set this

matter for hearing on February 27, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants granting the requested

suspension.

5. The application for authority to suspend CPCN PUC No. 55669 is in the public interest.

## II. **ORDER**

## A. **The Commission Orders That:**

- 1. The hearing set for February 27, 2004, is vacated.
- 2. This application was deemed complete on February 4, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Colorado Mountain Tours for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55669 is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55669 is authorized from December 10, 2003 through June 10, 2004.
- 5. On or before May 10, 2004, Colorado Mountain Tours shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55669 or to extend the suspension period.
- 6. Prior to reinstatement, Colorado Mountain Tours shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Colorado Mountain Tours shall also file a proper tariff and pay the appropriate vehicle identification fee.
- 7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55669 or to extend the suspension period may result in revocation of the certificate without further notice.
