I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On December 18, 2003, Mountain Mama's Delivery, Inc. (Mountain Mama's

Delivery) filed an application seeking authority to suspend operations under Certificate of Public

Convenience and Necessity (CPCN) PUC No. 55717.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on December 29, 2003. The Commission set this

matter for hearing on March 2, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants granting the requested

suspension.

5. The application for authority to suspend CPCN PUC No. 55717 is in the public interest.

II. **ORDER**

- A. **The Commission Orders That:**
- 1. The hearing set for March 2, 2004, is vacated.
- 2. This application was deemed complete on February 4, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Mountain Mama's Delivery for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55717 is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55717 is authorized from December 15, 2003 through May 1, 2004.
- 5. On or before April 1, 2004, Mountain Mama's Delivery shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55717 or to extend the suspension period.
- 6. Prior to reinstatement, Mountain Mama's Delivery shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Mountain Mama's Delivery shall also file a proper tariff and pay the appropriate vehicle identification fee.
- 7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55717 or to extend the suspension period may result in revocation of the certificate without further notice.
