## A. Statement, Findings and Conclusions

1. On January 5, 2004, Colorado Mobility, Inc., (Colorado Mobility) filed an

application seeking authority to suspend operations under Contract Carrier Permit No. B-9810.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on January 12, 2004. The Commission set this matter for hearing on March 12, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension.

5. The application for authority to suspend Contract Carrier Permit No. B-9810 is in the public interest.

## II. ORDER

### A. The Commission Orders That:

1. The hearing set for March 12, 2004, is vacated.

2. This application was deemed complete on February 18, 2004, within the meaning of § 40-6-109.5, C.R.S.

3. The application filed by Colorado Mobility, for authority to suspend operations under Contract Carrier Permit No. B-9810 is granted.

4. The suspension of motor vehicle operations under Contract Carrier Permit No. B-9810 is authorized from December 24, 2003 through June 24, 2004.

5. On or before May 24, 2004, Colorado Mobility shall file a written request either to reinstate Contract Carrier Permit No. B-9810 or to extend the suspension period.

6. Prior to reinstatement, Colorado Mobility shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Colorado Mobility shall also pay the appropriate vehicle identification fee.

7. The failure to file a timely written request either to reinstate Contract Carrier Permit No. B-9810 or to extend the suspension period may result in revocation of the certificate without further notice. Decision No. C04-0167
