# I. <u>BY THE COMMISSION:</u>

# A. Statement, Findings and Conclusions

1. On December 11, 2003, T F Transportation, LLC, with Mark Fefer as manager,

filed an application for approval to transfer Contract Carrier Permit No. B-9824 to T F Transportation, LLC, with Samvel Tatevosyan as manager.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 15, 2003. The Commission set this matter for hearing on February 17, 2004.

3. No petition to intervene or otherwise participate in this proceeding was filed. The proceeding was uncontested. The hearing of February 17, 2004, was vacated, and the requested transfer was granted by Decision No. C04-0071 on January 21, 2004.

4. On February 12, 2004, Mark Fefer, the manager of T F Transportation, LLC, filed a letter requesting the cancellation of the transfer application. In this letter, Mr. Fefer states

"Effective immediately please cancel this application to transfer Contract Carrier Permit No. B-9824 to Samvel Tatevosyan."

5. The Commission finds that Mark Fefer has shown good cause to dismiss the transfer application.

# II. ORDER

# A. The Commission Orders That:

1. The application filed by T F Transportation, LLC, with Mark Fefer as manager, for approval to transfer Contract Carrier Permit No. B-9824, to T F Transportation, LLC, with Samvel Tatevosyan as manager, is dismissed.

2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.
