**I. BY THE COMMISSION**

**A. Statement**

1. On February 17, 2004, Qwest Corporation (Qwest) filed a Notice of Modification to Exhibit B to the Ninth Revised Statement of Generally Available Terms and Conditions (SGAT) and Motion for Approval. In this Notice, Qwest states that it has updated Exhibit B to the SGAT and requests the Commission deem the updated Exhibit B to modify all existing interconnection agreements that contain the Performance Indicator Definitions (PIDs) at issue.

2. Qwest states that the modifications made to Exhibit B are the result of the Long Term PID Administration (LTPA) process. Qwest has attached the minutes from the December 18, 2003 LTPA meeting at which time discussion was held on the modifications and consensus was reached.

3. Specifically, with this filing, Qwest seeks to modify PO-16, Timely Release Notifications, GA-1, Gateway Availability – IMA GUI, and to make typographical corrections, update outdated information and make certain phrases and terms consistent throughout the PIDs. PO-16 has been modified to correct an administrative oversight. The version of PO-16 that was

previously filed inadvertently omitted some of the intended red-lined changes; however, Qwest asserts that it has been reporting its monthly performance according to the correct version of PO-16.

4. GA-1 has been changed to reflect the retirement of two interface components, Fetch-N-Stuff (GA-1B) and Data Arbiter (GA-1C). These components have been replaced with one interface component, SIA (GA-1D), which facilitates access for the IMA GUI and the IMA EDI interface, and reports the percentage of scheduled time the SIA system is available.

5. Qwest requests that the updated Exhibit B be allowed to go into effect within 60 days in accordance with 47 U.S.C. § 252(f)(3) and that all existing interconnection agreements that currently contain the PIDs as an exhibit, be deemed modified with the approval of this Notice without need for further amendments.

6. Qwest noticed this filing on March 4, 2004, through its mailouts process for SGAT changes. No responses were received from any party and the minutes from the LTPA meeting demonstrate acceptance of these changes by all participants. Therefore, we approve these changes and allow them to go into effect without modification.

7. All revisions approved in this decision shall be applicable without further amendment to any PIDs incorporated into an existing ICA, any ICA pending before the Commission, and any ICA amendment delivered to a competitive local exchange carrier but not yet executed or submitted to the Commission for approval. This decision is consistent with past Commission actions, and will lessen the administrative burden on both Qwest and other telecommunications providers.

**II. ORDER****A. The Commission Orders That:**

1. Qwest Corporation's Notice of Modification to Exhibit B to the Ninth Revised Statement of Generally Available Terms and Conditions and Motion for Approval is approved consistent with the above discussion.

2. Qwest Corporation is ordered to file an advice letter and tariff pages to make corresponding changes to its Local Network Interconnection and Service Resale Tariff, PUC No. 22, within 30 days of the Mailed Date of this Decision.

3. This Order is effective on its Mailed Date.
