A. Statement, Findings and Conclusions

- 1. On March 12, 2004, Denver Mountain Express, Inc., doing business as Amerishuttle &/or Blue Sky Shuttle filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC Nos. 50790, 52940, 55363, 55519, and L22485.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on March 22, 2004. The Commission set this matter for hearing on April 28, 2004.
- 3. On March 24, 2004, Denver Mountain Express, Inc., doing business as Amerishuttle &/or Blue Sky Shuttle filed a letter requesting a withdrawal of the application to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC Nos. 50790, 52940, 55363, 55519, and L22485.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for April 28, 2004, is vacated.
- 2. The motion filed by Denver Mountain Express, Inc., doing business as Amerishuttle &/or Blue Sky Shuttle to withdraw the application for authority to suspend operations under Certificate of Public Convenience and Necessity PUC Nos. 50790, 52940, 55363, 55519, and L22485 is granted.
- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.
