COMMISSION ORDER DISMISSING TRANSFER OF CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On December 18, 2003, Samja's Enterprises, Inc., doing business as Express Airport Taxi/Express Taxi (Express Airport Taxi) filed an application for approval to transfer Certificate of Public Convenience and Necessity (CPCN) PUC No. 55670 to RDSM Transportation Ltd., doing business as Express Taxi (RDSM).

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on December 29, 2003. The Commission set this matter for hearing on March 4, 2004.

3. Metro Taxi, Inc. filed an intervention to this application on January 7, 2004.

4. On January 26, 2004, Metro Taxi, Inc. and Express Airport Taxi, and RDSM filed a Stipulated Motion to Cancel a Portion of CPCN PUC No. 55670, as a condition to approving the transfer of the remaining portions of CPCN PUC No. 55670 and conditional withdrawal of intervention.

5. The transfer of the remaining portion of CPCN PUC No. 55670 from Express Airport Taxi to RDSM, was granted by Decision No. R04-0145 on February 6, 2004.

6. Duane H. Kamins, the President of RDSM on March 25, 2003, filed a request to dismiss the application in Docket No. 03A-546CP-Transfer. In this request, Mr. Kamins states: "RDSM Transportation Ltd., has terminated the negotiations for the purchase of the assests of Samja's Enterprises, Inc., and hereby requests that the application in the above-referenced Docket be dismissed."

II. ORDER

A. The Commission Orders That:

1. The application filed by Samja's Enterprises, Inc., doing business as Express Airport Taxi/Express Taxi for approval to transfer Certificate of Public Convenience and Necessity PUC No. 55670, subject to encumbrances, if any, against the authority, to RDSM Transportation, Ltd., doing business as Express Taxi, is dismissed.

2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.
