I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On February 23, 2004, Richard J. Calvert, doing business as Top of the Rockies Taxi Service (Top of the Rockies Taxi Service), filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55718.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on March 8, 2004. The Commission set this matter for hearing on May 7, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension.

5. The application for authority to suspend CPCN PUC No. 55718 is in the public interest.

II. ORDER

A. The Commission Orders That:

1. The hearing set for May 7, 2004, is vacated.
2. This application was deemed complete on April 21, 2004, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed Top of the Rockies Taxi Service for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55718 is granted.
4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55718 is authorized from February 10, 2004 through August 10, 2004.
5. On or before July 9, 2004, Top of the Rockies Taxi Service shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55718 or to extend the suspension period.
6. Prior to reinstatement, Top of the Rockies Taxi Service shall cause to be filed with the Commission certificates of insurance as required by Commission rules.
7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55718 or to extend the suspension period may result in revocation of the certificate without further notice.

8. This Order is effective on its Mailed Date.
