I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On April 12, 2004, Durango Transportation, Inc. (Durango Transportation) filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 14196.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on April 19, 2004. The Commission set this matter for hearing on July 15, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension.

5. The application for authority to suspend CPCN PUC No. 14196 is in the public interest.

II. ORDER

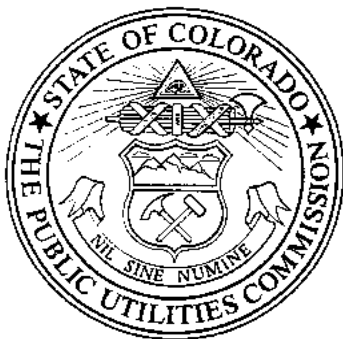
A. The Commission Orders That:

1. The hearing set for July 15, 2004, is vacated.
2. This application was deemed complete on May 26, 2004, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed by Durango Transportation, Inc. for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 14196 is granted.
4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 14196 is authorized from April 12, 2004 through April 22, 2004.
5. The 20-day time period provided by §40-6-141(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

6. This Order is effective on its Mailed Date.
