I. <u>BY THE COMMISSION:</u>

A. Statement

1. On May 10, 2004, Durango Transportation, Inc. (DTI) filed an application for

authority to publish increased rates for the transportation of passengers in taxi and limousine

service in the southwest Colorado region to become effective on less-than-statutory notice.

2. DTI's proposed rate increases range from 25 to 53.3 percent. Notice has been

published and posted in offices and vehicles in accordance with Rule 31 of the Commission's

Rules of Practice and Procedure, 4 Code of Colorado Regulations 723-1. DTI states in support

of the application that gasoline and insurance costs have compelled this application to be filed

less than statutory notice.

3. Rule 31(f)(1) of the Commission's Rules of Practice and Procedure, 4 Code of

Colorado Regulations 723-1, allows an order authorizing carriers to change tariffs or time

schedules on less-than-statutory notice for good cause shown.

4. No objections to this application have been received by the Commission.

- 2. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.
