I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On May 6, 2004, Mountain Goat Tours, Inc., filed an application seeking authority

to suspend operations under Certificates of Public Convenience and Necessity (CPCN) PUC

Nos. 55675 & 54655.

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on May 17, 2004. The Commission set this

matter for hearing on July 23, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

4. The information submitted with this application warrants granting the requested

suspension.

5. The application for authority to suspend CPCN PUC Nos. 55675 & 54655 is in the public interest.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for July 23, 2004, is vacated.
- 2. This application was deemed complete on June 22, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Mountain Goat Tours, Inc., for authority to suspend operations under Certificates of Public Convenience and Necessity PUC Nos. 55675 & 54655 is granted.
- 4. The suspension of motor vehicle operations under Certificates of Public Convenience and Necessity PUC Nos. 55675 & 54655 is authorized from May 18, 2004 through November 18, 2004.
- 5. On or before October 18, 2004, Mountain Goat Tours, Inc., shall file a written request either to reinstate Certificates of Public Convenience and Necessity PUC Nos. 55675 & 54655 or to extend the suspension period.
- 6. Prior to reinstatement, Mountain Goat Tours, Inc., shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Mountain Goat Tours, Inc., shall also file a proper tariff and pay the annual vehicle identification fee.
