**COMMISSION ORDER APPROVING TRANSFER OF
CERTIFICATE OF PUBLIC CONVENIENCE
AND NECESSITY**

I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On May 10, 2004, David Carrel, doing business as Lift Ticket Limo, (Lift Ticket Limo), filed an application for approval to transfer Certificate of Public Convenience and Necessity (CPCN) PUC No. 55715 to Lift Ticket Limo, LLC, (Lift Ticket Limo, LLC).

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on May 17, 2004. The Commission set this matter for hearing on August 2, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested transfer.

5. The financial standing of Lift Ticket Limo, LLC, has been satisfactorily established.

6. Lift Ticket Limo, LLC, is ready, willing, and able properly to perform the service as requested.

7. This application for permanent approval of the transfer of CPCN PUC No. 55715 is in the public interest.

II. ORDER

A. The Commission Orders That:

1. The hearing set for August 2, 2004, is vacated.
2. This application was deemed complete on June 22, 2004, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed by Lift Ticket Limo for approval to transfer Certificate of Public Convenience and Necessity PUC No. 55715, subject to encumbrances, if any, against the authority, to Lift Ticket Limo, LLC, is granted.
4. Lift Ticket Limo, LLC, shall operate in accordance with all applicable Commission rules and regulations.
5. Approval of the transfer of Certificate of Public Convenience and Necessity PUC No. 55715 is conditioned on the prior filing by Lift Ticket Limo of delinquent reports, if any, covering operations under the certificate up to the consummation of the transfer.

6. Lift Ticket Limo, LLC, shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Lift Ticket Limo, LLC, shall also adopt the tariff of Lift Ticket Limo which shall become that of Lift Ticket Limo, LLC, until changed in accordance with the public utilities law. Lift Ticket Limo, LLC, shall pay the issuance fee and the annual vehicle identification fee. Lift Ticket Limo shall file a terminating annual report from the first of January to the date of this Order. An acceptance of transfer signed by both Lift Ticket Limo and Lift Ticket Limo, LLC, shall be filed with the Commission. Lift Ticket Limo, LLC, may not begin operations until these requirements have been met and it has received notice in writing from the Commission stating that it is in compliance and may begin service.

7. If Lift Ticket Limo and Lift Ticket Limo, LLC, do not comply with the requirements of this Order within 60 days of its effective date, then the approval to transfer Certificate of Public Convenience and Necessity PUC No. 55715 shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

8. This Order is effective immediately on its Mailed Date.
