#### A. Statement

1. This matter comes before the Commission for consideration of the Applications

for Rehearing, Reargument, or Reconsideration (RRR) filed by K N Wattenberg Transmission

Limited Liability Co.; Excel Corporation and Leprino Foods Company; the City of Fort Morgan;

and Commission Staff. The applications request reconsideration of Decision Nos. C02-1224 and

Pursuant to the provisions of § 40-6-114(1), C.R.S., the Commission must act upon the applications within 30 days, or by July 7, 2004, or the applications will be deemed denied by operation of law.
