**COMMISSION ORDER GRANTING EXTENSION  
TO CERTIFICATE OF PUBLIC CONVENIENCE  
AND NECESSITY**

**I. BY THE COMMISSION:**

**A. Statement, Findings and Conclusions**

1. On May 20, 2004, Broadmoor Hotel, Inc. doing business as Broadmoor Hotel Garage (Broadmoor Hotel) filed an application for permanent authority to extend operations under Certificates of Public Convenience and Necessity PUC No. L275 and 275 by deleting Restriction A to Item (I). The existing authority, with Restriction A to Item (1) indicated in bold, read as follows:

I. Transportation in sightseeing service of passengers between all points within Colorado Springs, Colorado, and between said points, on the one hand, and all points within the Pikes Peak region, on the other hand. II. Transportation in call and demand limousine service of passengers and their baggage between all points within Colorado Springs, Colorado, and between said points, on the one hand, and all points within the State of Colorado, on the other hand. Restrictions: This

Certificate is restricted as follows: **Item (I) is restricted (A) against the use of vehicles with a passenger capacity of 32 or more;** and (B) to providing sightseeing service which originates and terminates at the same point, except when providing sightseeing service between Colorado Springs, Colorado, and the Summit of Pikes Peak, in which case one-way service may be provided from Colorado Springs, Colorado, to the Summit of Pikes Peak or from the Summit of Pikes Peak to Colorado Springs, Colorado.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 1, 2004. The Commission set this matter for hearing on August 4, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested extension.

5. This application for permanent authority is in the public interest.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The hearing set for August 4, 2004, is vacated.
2. This application was deemed complete on July 9, 2004, within the meaning of § 40-6-109.5, C.R.S.

3. Broadmoor Hotel is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. L275, 275 as requested in this application.

4. The complete authority under Certificate of Public Convenience and Necessity PUC No. L275 and 275, as extended, shall be as set forth in the Appendix.

5. Broadmoor Hotel shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Broadmoor Hotel shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Extended operations may not begin until these requirements have been met.

6. If Broadmoor Hotel does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

7. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

8. This Order is effective on its Mailed Date.
