I. <u>BY THE COMMISSION</u>

A. Statement

1. This matter comes before the Commission for consideration of a Motion for

Waiver of Requirement Contained in Decision No. C97-88 to Report Missed Installation

Appointments and Associated Billing Credits, filed by Qwest Corporation (Qwest) on July 8,

2004.

2. Decision No. C97-88, *inter alia*, required Qwest, formerly known as U S WEST

Communications, Inc., to submit quarterly reports to the Commission on the number of missed

service installation appointments and the associated billing credits, including a disaggregation of

multiple bill credits.<sup>1</sup> Qwest was also required to file such reports for at least one year. The

Commission required that Qwest file at lease four reports before it could request relief from this

requirement.

3. Qwest now comes to the Commission seeking relief from this requirement. Qwest indicates that it has continued to comply with the requirements of Decision No. C97-88 and has filed 27 consecutive reports with the Commission. Despite the expiration of the initial five-year plan for rate and service regulation, Qwest represents that it continued to provide these reports to the Commission. Indeed, Qwest additionally included a copy of its most recent report for missed installation appointments and related billing credits for the first quarter of 2004 with its motion.

4. We find Qwest has stated good cause and therefore grant its motion. We point out that Qwest filed its pleading here as both an application to discontinue its reporting obligations pursuant to Decision No. C97-88, and a motion for waiver of the same requirement. We will treat the filing as a motion to discontinue the reporting requirements at issue.

## II. ORDER

## **A.** The Commission Orders That:

- The motion of Qwest Corporation to discontinue filing quarterly reports of missed installation appointments and associated billing credits as required pursuant to Decision No. C97-88 is granted.
- 2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Mailed Date of this Order.
  - 3. This Order is effective on its Mailed Date.
