I. BY THE COMMISSION:

A. Statement, Findings and Conclusions

1. On May 11, 2004, Sergej Pachomow doing business as Powderline Shuttle

(Powderline Shuttle), filed an application for permanent authority to extend operations under

Certificate of Public Convenience and Necessity PUC No. 55730 to include the transportation of

passengers and their baggage, in call-and-demand limousine service and in charter service,

between all points in the County of Summit, State of Colorado, on the one hand, and all points in

the Counties of Denver, Eagle, and Jefferson, State of Colorado, on the other hand. This

application is restricted: (I) To providing transportation service that originates or terminates in

the County of Summit, State of Colorado; and (II) Against providing transportation service to or

from Denver International Airport, Denver, Colorado.

- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on June 28, 2004. The Commission set this matter for hearing on August 31, 2004.
- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
- 4. The information submitted with this application warrants granting the requested extension.
- 5. The present or future public convenience and necessity requires, or will require, the transportation service as requested.
- 6. Powderline Shuttle is ready, willing, and able to properly perform the service as requested.
 - 7. This application for permanent authority is in the public interest.

II. ORDER

A. The Commission Orders That:

- 1. The hearing set for August 31, 2004, is vacated.
- 2. This application was deemed complete on August 3, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. Powderline Shuttle is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. 55730 as requested in this application.
- 4. The complete authority under Certificate of Public Convenience and Necessity PUC No. 55730, as extended, shall be as set forth in the Appendix.

- 5. Powderline Shuttle shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Powderline Shuttle shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Powderline Shuttle may not begin extended operations until these requirements have been met and it has received a letter from the Commission stating it is in compliance and may begin service.
- 6. If Powderline Shuttle does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
- 7. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- 8. This Order is effective on its Mailed Date.

- I. Transportation of passengers and their baggage, in call-and-demand limousine service and in charter service, between all points within a five-mile radius of the intersection of Colorado Highways 9 and I-70, Frisco, Colorado, on the one hand, and (I) all points within a five-mile radius of the intersection of U. S. Highway 40 and Old Town Drive, Winter Park, Colorado; and (II) all points in Eagle County, State of Colorado, on the other hand.
- II. Transportation of passengers and their baggage, in call-and-demand limousine service and in charter service, between all points in the County of Summit, State of Colorado, on the one hand, and all points in the Counties of Denver, Eagle, and Jefferson, State of Colorado, on the other hand.

Item II of this Certificate is restricted as follows:

- A. To providing transportation service that originates or terminates in the County of Summit, State of Colorado; and
- B. Against providing transportation service to or from Denver International Airport, Denver, Colorado.
