**I. BY THE COMMISSION:**

**A. Statement, Findings and Conclusions**

1. On June 30, 2004, Sergej Pachomow doing business as Powderline Shuttle (Powderline Shuttle), filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55730.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 12, 2004. The Commission set this matter for hearing on September 16, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension.

5. Suspension of service provided under CPCN PUC No. 55730 is in the public interest.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The hearing set for September 16, 2004, is vacated.
2. This application was deemed complete on August 18, 2004, within the meaning of § 40-6-109.5, C.R.S.
3. The application filed by Powderline Shuttle for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55730 is granted.
4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55730 is authorized from July 28, 2004, through November 15, 2004.
5. On or before October 15, 2004, Powderline Shuttle shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55730 or to extend the suspension period.
6. Prior to reinstatement, Powderline Shuttle shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Powderline Shuttle shall also file a proper tariff and pay the appropriate vehicle identification fee.
7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55730 or to extend the suspension period may result in revocation of the certificate without further notice.

8. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

9. This Order is effective on its Mailed Date.
