## I. <u>BY THE COMMISSION:</u>

#### A. Statement, Findings and Conclusions

- 1. By an application filed July 15, 2004, Boulder Taxi, LLC, doing business as Boulder Yellow Cab &/or Super Shuttle Airport Van (Boulder Yellow Cab), requests a waiver of Rule 25.5 (Age of Vehicles) of the Rules, Regulations, and Civil Penalties Governing Common Carriers of Passengers by Motor Vehicle For Hire, 4 CCR 723-31. The waiver request pertains to operations conducted under Certificate of Public Convenience and Necessity PUC No. 150&I. The vehicle for which the waiver is requested is a 1994 Chevrolet Caprice with a Vehicle Identification Number of 1G1BL52P6RR179542. The waiver is requested from July 1, 2004 to July 1, 2005.
- 2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on July 26, 2004. The Commission set this matter for hearing on September 27, 2004.

- 3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is therefore uncontested. Under Rules 24 and 59(g), *Rules of Practice and Procedure*, 4 CCR 723-1, this matter may be determined without a hearing.
- 4. Commission Rule 25.5, 4.CCR 723-31 prohibits a carrier from using vehicles older than ten model years as of July 1<sup>st</sup> in taxi service. Rule 25.5, 4.CCR 723-31 states

Taxicab vehicles shall be no older than six model years as of July 1<sup>st</sup> of each year. For the purpose of this rule, model years shall be counted from the present calendar year and shall include the present calendar year and the five previous calendar years. Vehicles that are older than six model years but not more than tem model years, may be exempted from this rule. To qualify for the exemption, the vehicle, at the time of its periodic inspection, must be in outstanding physical condition in the opinion of the Commission's safety inspector.

- 5. The 1994 Chevrolet Caprice identified in this application is over ten model years old as of July 1, 2004. Therefore, unless Boulder Yellow Cab is granted a waiver of Rule 25.5, 4 CCR 723-31 for the vehicle named in this application, Boulder Yellow Cab must stop providing taxi service with this vehicle.
- 6. In support of this application, Boulder Yellow Cab states "The reason for this petition for waiver is to avoid a financial hardship for the driver. Six to eight months should be sufficient time for the owner/driver to purchase a newer car."
- 7. The Commission finds that the information submitted with this application warrants the granting of a waiver of Rule 25.5, 4 CCR 723-31.
- 8. Commission staff inspected this vehicle on August 5, 2004, and found it to be in safe operating condition and good overall condition.

9. However, Boulder Yellow Cab is advised that the granting of the waiver of Rule 25.5, 4 CCR 723-31 for the vehicle named in this application does not ensure that this vehicle will pass a future safety inspection by staff of the Commission.

# II. ORDER

#### A. The Commission Orders That:

- 1. Boulder Yellow Cab is granted a waiver of Rule 25.5, 4 *Code of Colorado Regulations* 723-31; *Rules, Regulations, and Civil Penalties Governing Common Carriers of Passengers by Motor Vehicle Carriers Exempt From Regulation as Public Utilities* for the 1994 Chevrolet Caprice named in this application. The term of this waiver shall be from July 1, 2004, through July 1, 2005.
  - 2. The hearing set for September 27, 2004, is vacated.
- 3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails this Order.
  - 4. This Order is effective on its Mailed Date.
