THE APPLICATION OF OWNER/DRIVER UNITED CORPORATION DOING BUSINESS AS BLUE SKY SHUTTLE FOR TEMPORARY APPROVAL TO ALLOW GOLDEN WEST COMMUTER, LLC TO ASSUME OPERATIONAL CONTROL OF CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY PUC NO. 55725.

I. <u>BY THE COMMISSION:</u>

A. Statement

- 1. On August 19, 2004, Owner/Driver United Corporation doing business as Blue Sky Shuttle (Blue Sky Shuttle), filed an application for temporary approval to allow Golden West Commuter, LLC (Golden West Commuter) to assume operational control of Certificate of Public Convenience and Necessity (CPCN) PUC No. 55725 pending Commission consideration of the related application to permanently lease the certificate.
 - 2. The Commission gave notice of the application on August 23, 2004.
 - 3. There are no interventions opposing the application.
- 4. Pursuant to § 40-6-120(2), C.R.S., the Commission may grant temporary approval of a certificate transfer "if it appears that failure to grant such temporary approval may result in destruction of or injury to such carrier or carrier properties sought to be acquired, or to interfere

substantially with their future usefulness in the performance of adequate and continuous service to the public."

B. Findings of Fact

- 5. Boulder Express, LLC dba Boulder Express Shuttle was granted approval to transfer CPCN PUC No. 55725 to Blue Sky Shuttle by Decision No. C04-0421 in Docket No. 04A-100CP on April 29, 2004. Blue Sky Shuttle is authorized by CPCN PUC No. 55725 to provide call-and-demand limousine service between Denver International Airport (DIA) and points in the southeastern portion of the Denver metropolitan area.
- 6. Golden West Commuter is authorized to provide scheduled service between Denver International Airport and points in the western portion of the Denver metropolitan area. Golden West Commuter has had an airport customer and ticket counter at DIA since the airport opened in 1995.
- 7. In support of this application Blue Sky Shuttle states "We are currently without a customer service and ticket counter at DIA. Passengers are forced to search out Blue Sky Shuttle on the outer rungs of the airport without assistance. This is impeding service to the public. Blue Sky Shuttle has a number of convention bookings coming up in the immediate future. It will be difficult to service these passengers adequately without the customer service and ticket counter these people rely on to assist them with their travel plans. No new service is being requested in this application only the ability to more adequately serve passengers under an existing certificate."
- 8. The information filed by Blue Sky Shuttle in support of this temporary authority application is rather limited. The application does not include any statement regarding the status

of Blue Sky Shuttle's Public Liability and Property Insurance. Common Carrier Rule 4 (CCR) 723-31-12.2 requires every common carrier to obtain and keep in force the appropriate Public Liability and Property Insurance. The Commission has received notice from Blue Sky Shuttle's insurance carrier, Lincoln General Insurance Company, that Blue Sky Shuttle's liability insurance currently on file with the Commission was to be cancelled as of September 4, 2004.

- 9. Therefore, the Commission will take into consideration that Blue Sky Shuttle may have to cease all operations as of September 4, 2004. The cessation of service by Blue Sky Shuttle could decrease the scheduled and call-and demand service that is presently available to the traveling public.
- 10. Granting this application will allow potential passengers to more easily find the services currently provided under CPCN PUC No. 55725, thus preventing harm to the CPCN.

C. Conclusions

- 11. The Commission finds that Blue Sky Shuttle has shown that a failure to grant temporary approval of an assumption of operational control could result in injury to CPCN PUC No. 55725 and ultimately affect service to the public.
- 12. Golden West Commuter has adequate equipment and financial resources to begin immediate service within the scope of the authority sought.
 - 13. This application for temporary approval is in the public interest.
- 14. Blue Sky Shuttle and Golden West Commuter are advised that the grant of temporary approval of an assumption of operational control creates no presumption that permanent lease approval will be granted.

II. ORDER

A. The Commission Orders That:

- The application for temporary approval of an assumption of operational control by Golden West Commuter of Certificate of Public Convenience and Necessity PUC No. 55725 as filed by Blue Sky Shuttle is granted.
- Golden West Commuter is granted temporary approval to assume operational control of Certificate of Public Convenience and Necessity PUC No. 55725 for a period of 150 days commencing from the Mailed Date of this Order.
- 3. Golden West Commuter shall operate Certificate of Public Convenience and Necessity PUC No. 55725 in accordance with all applicable Commission rules and regulations.
- 4. Golden West Commuter shall not assume operational control until it has adopted the tariff of Blue Sky Shuttle and it has received notice in writing from the Commission stating that it is in compliance and may begin service.
- 5. If Golden West Commuter does not comply with the requirements of this Order within 30 days of its effective date, then the temporary approval shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 30 days.
- 6. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- 7. This Order is effective on its Mailed Date.
