I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On August 2, 2004, Alan Griffin and Wayne Groome, doing business as Historical

Trolley Tour (Historical Trolley Tour), filed an application seeking authority to suspend

operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55706S

from July 15, 2004, through September 30, 2004.

2. Historical Trolley Tour, under CPCN PUC No. 55706S, is restricted to providing

service between May 15 and September 30 of the same year.

3. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on August 9, 2004. The Commission set this

matter for hearing on October 13, 2004.

4. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

- 6. The application for authority to suspend CPCN PUC No. 55706S is in the public interest.

## II. **ORDER**

## A. **The Commission Orders That:**

- 1. The hearing set for October 13, 2004, is vacated.
- 2. This application was deemed complete on September 14, 2004, within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Historical Trolley Tour for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55706S is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55706S is authorized from July 15, 2004, through September 30, 2004.
- 5. Prior to reinstatement, Historical Trolley Tour shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Historical Trolley Tour shall also file a proper tariff and pay the appropriate vehicle identification fee.
- 6. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.
