**I. BY THE COMMISSION:**

**A. Statement, Findings and Conclusions**

1. On August 12, 2004, Richard J. Calvert, doing business as Top of the Rockies Taxi Service (Top of the Rockies Taxi Service), filed an application seeking authority to suspend operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55718 from August 10, 2004 through February 10, 2005.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on August 23, 2004. The Commission set this matter for hearing on October 26, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested suspension.

5. The application for authority to suspend CPCN PUC No. 55718 is in the public interest.

## **II. ORDER**

### **A. The Commission Orders That:**

1. The hearing set for October 26, 2004, is vacated.

2. This application was deemed complete on September 29, 2004, within the meaning of § 40-6-109.5, C.R.S.

3. The application filed by Top of the Rockies Taxi Service for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55718 is granted.

4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55718 is authorized from August 10, 2004 through February 10, 2005.

5. On or before January 10, 2005, Top of the Rockies Taxi Service shall file a written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55718 or to extend the suspension period.

6. Prior to reinstatement, Top of the Rockies Taxi Service shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Top of the Rockies Taxi Service shall also file a proper tariff and pay the appropriate vehicle identification fee.

7. The failure to file a timely written request either to reinstate Certificate of Public Convenience and Necessity PUC No. 55718 or to extend the suspension period may result in revocation of the certificate without further notice.

8. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

9. This Order is effective on its Mailed Date.
