I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission for consideration of an Application for

a Certificate of Public Convenience and Necessity (CPCN) to Provide Local Exchange

Telecommunications Services filed by Applicant InTTec, Inc. (InTTec or Applicant), on

September 15, 2004.

2. Staff of the Public Utilities Commission (Staff) sent a letter to the Contact Person

identified in InTTec's application requesting further information concerning InTTec's financial

and managerial fitness to provide telecommunications services in Colorado. Staff's letter also

stated that the application lacked the required affidavit and a stamped authority issued by the

Colorado Secretary of State's office. Staff requested that InTTec respond to the inquires by

September 30, 2004.

3. InTTec failed to respond to Staff's questions. The Application form for a CPCN

includes a statement that by signing the form, the Applicant "Agrees to answer all questions

posed by the Commission or any authorized member of its Staff concerning the application..."

Mr. Brian Worthen, General Manager for InTTec, agreed to this statement in signing the Application on behalf of InTTec.

- 4. Rule 4 *Code of Colorado Regulations* 723-25-3.4 states that deficiencies not cured within 30 days of the Commission's receipt of the application shall result in rejection and the docket shall be closed. The 30-day period expired on October 14, 2004 with no additional information filed by the Applicant
- 5. Because of InTTec's failure to respond to Staff's questions concerning the Application in a timely manner as required by Commission rule, we reject its application for authority. InTTec may reapply for certification at a future date of its closing.

II. ORDER

A. The Commission Orders That:

- 1. InTTec, Inc.'s Application for a Certificate of Public Convenience and Necessity to Provide Local Exchange Telecommunications Services is rejected without prejudice and this docket is closed. InTTec, Inc. is free to reapply at a future date.
- 2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Mailed Date of this Order.
 - 3. This Order is effective on its Mailed Date.
