**I. BY THE COMMISSION**

**A. Statement**

1. By Decision No. C04-1296, we ordered Qwest Corporation (Qwest) to publish an additional notice in the form of an advertisement in the *Denver Post* and *Rocky Mountain News*. This additional notice was required because of our decision on Commission Staff's Petition for Declaratory Order. *See* Decision No. C04-1296. The Commission approved advertisement was attached to that Decision as Attachment B.

2. It has come to our attention that due to the mailed date of our Decision, this notice was not published before November 10, 2004, the intervention deadline. The language in the Commission-ordered advertisement contains the November 10, 2004 date. To avoid customer

confusion, we now edit the ad to delete the intervention date and emphasize that comments can be filed in the docket at any point up to the hearing dates. If there are parties who wish to intervene after the November 10, 2004 date, those Motions for Late Interventions will be analyzed on their merits.

3. Qwest is ordered to publish the attached revised notice as soon as possible.

**II. ORDER**

**A. The Commission Orders That:**

1. Qwest Corporation is ordered to publish the advertisement found in Attachment A to this Decision in the *Denver Post* and the *Rocky Mountain News*.
