DECISION GRANTING JOINT MOTION FOR APPROVAL OF AMENDMENT TO THE INTERCONNECTION AGREEMENT

I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission on the joint motion of Qwest

Corporation (Qwest) and Complete Telecommunications, Inc., formerly known as

VR Telecommunications, Inc. (Complete), for approval of amendments to their Interconnection

Agreement (Agreement). The Agreement was initially approved in Decision No. C00-1383,

issued December 8, 2000.

2. The Parties filed these negotiated amendments on October 7, 2004. The Parties

have decided to amend the Agreement to add rates, terms, and conditions for Commercial Shared

Distribution Loop and Commercial Line Sharing. Under the terms of 47 U.S.C. § 252(i) of the

Telecommunications Act of 1996, Complete may at some future date opt into the terms and

conditions of Commission approved and currently effective agreements:

[a] local exchange carrier shall make available any interconnection, service, or network element provided under an agreement approved under this section to Decision No. C04-1343 DOCKET NO. 00T-611

which it is a party to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement.

- 3. Section 47 U.S.C. § 251 *et seq.* of the Act requires that the Commission review and approve or reject interconnection agreements involving incumbent local exchange carriers like Qwest. To comply with the Act, rates in negotiated agreements must be just and reasonable, nondiscriminatory, and based on the cost of providing the interconnection or network element. 47 U.S.C. § 252(e). In reviewing agreements (or portions thereof) the Commission, generally, is guided by 47 U.S.C. § 252(e)(2), requiring that interconnection agreements not discriminate against non-parties and be consistent with the public interest, convenience, and necessity.
- 4. The proposed rates and conditions have not been previously approved but are supported by cost studies on file in Docket No. 99A-577T. We therefore find it consistent with the directives of the Act, and our own interconnection agreement rules to approve the present amended terms and conditions subject to our own rules and general ratemaking proceedings.

## II. ORDER

## **A.** The Commission Orders That:

- 1. The joint motion of Qwest Corporation and Complete Telecommunications, Inc. to amend their Interconnection Agreement is granted.
