I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On October 1, 2004, Odd Lyngholm doing business as American Wilderness Tours

(American Wilderness Tours) filed an application seeking authority to temporarily suspend

operations under Certificate of Public Convenience and Necessity (CPCN) PUC No. 55677S

from October 1, 2004 through October 15, 2004.

2. American Wilderness Tours is authorized by CPCN PUC No. 55677S to provide

transportation service between May 15 and October 15 of the same year.

3. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on October 18, 2004. The Commission set this

matter for hearing on November 30, 2004.

4. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

- 5. The information submitted with this application warrants granting the requested suspension.
- 6. The application for authority to suspend CPCN PUC No. 55677S is in the public interest.

## II. ORDER

## **A.** The Commission Orders That:

- 1. The hearing set for November 30, 2004, is vacated.
- 2. This application was deemed complete on November 23, 2004 within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by American Wilderness Tours for authority to suspend operations under Certificate of Public Convenience and Necessity PUC No. 55677S is granted.
- 4. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 55677S is authorized from October 1, 2004 through October 15, 2004.
- 5. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- 6. This Order is effective on its Mailed Date.
