I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On October 12, 2004, Vail Summit Resorts, Inc. doing business as Keystone Resort, Inc. (Keystone Resort), filed an application for permanent authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 20195 to include the transportation of passengers and their baggage, in scheduled and call-and-demand limousine service between all points located within a five-mile radius of the intersection of U. S. Highway 6 and West Keystone Road, in Summit County, Colorado.

2. The Commission noticed this application to all interested persons, firms, and corporations pursuant to § 40-6-108(2), C.R.S., on October 18, 2004. The Commission set this matter for hearing on December 27, 2004.

3. No petition to intervene or otherwise participate in this proceeding has been filed. This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

4. The information submitted with this application warrants granting the requested extension.

5. The present or future public convenience and necessity requires, or will require, the transportation service as requested.

6. Keystone Resort is ready, willing, and able to properly perform the service as requested.

7. This application for permanent authority is in the public interest.

II. ORDER

A. The Commission Orders That:

1. The hearing set for December 27, 2004, is vacated.

2. This application was deemed complete on November 23, 2004 within the meaning of § 40-6-109.5, C.R.S.

3. Keystone Resort is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. 20195 as requested in this application.

4. The complete authority under Certificate of Public Convenience and Necessity PUC No. 20195, as extended, shall be as set forth in the Appendix.

5. Keystone Resort shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Keystone Resort shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Keystone Resort may not begin extended

operations until these requirements have been met and it has received notice in writing from the Commission stating it is in compliance and may begin service.

6. If Keystone Resort does not comply with the requirements of this Order within 60 days of its effective date, then the authority to conduct operations shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.

7. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- I. Transportation of passengers and their baggage, on schedule, between all points located within Keystone, County of Summit, State of Colorado, namely Sections 23, 24, 27, and 34, Township 5 South, Range 77 West of the 6th P.M., and Section 19, Township 5 South, Range 76 West of the 6th P.M., on the one hand, and, on the other hand, all points within a five-mile radius of the intersection of Quebec Street and Martin Luther King Parkway in Denver, Colorado.
- II. Transportation of passengers and their baggage, in charter service, between all points in Keystone, County of Summit, State of Colorado, namely Sections 23, 24, 27, and 34, Township 5 South, Range 77 West of the 6th P.M., and Section 19, Township 5 South, Range 76 West of the 6th P.M., on the one hand, and Denver International Airport, on the other hand.
- III. Transportation of passengers and their baggage, in scheduled and call-and demand limousine service, between all points located within a five-mile radius of the intersection of U.S. Highway 6 and West Keystone Road, in Summit County, Colorado.

RESTRICTIONS:

- A. Item No. I is restricted to providing service only to points named in the carrier's published schedule; and
- B. Item No. I is restricted against providing service to or from Union Station or to or from the Fairmont Hotel both in Denver, Colorado.Transportation of passengers and their baggage in scheduled and call-and-demand limousine service between all points located within a five-mile radius of the intersection of U. S. Highway 6 and West Keystone Road, in Summit County, Colorado.
