I. <u>BY THE COMMISSION:</u>

A. Statement, Findings and Conclusions

1. On November 10, 2004 Boulder Taxi, LLC doing business as Boulder Yellow Cab

&/or Super Shuttle Airport Van (Boulder Yellow Cab) filed an application for approval to transfer

Certificate of Public Convenience and Necessity (CPCN) PUC No. 150 & I to Colorado Cab

Company LLC (Colorado Cab Company).

2. The Commission noticed this application to all interested persons, firms, and

corporations pursuant to § 40-6-108(2), C.R.S., on November 15, 2004. The Commission set this

matter for hearing on January 18, 2005.

3. No petition to intervene or otherwise participate in this proceeding has been filed.

This proceeding is uncontested. Under § 40-6-109(5), C.R.S., this matter may be determined

without a hearing.

- 4. The information submitted with this application warrants granting the requested transfer.
- 5. The financial standing of Colorado Cab Company has been satisfactorily established.
- 6. Colorado Cab Company is ready, willing, and able to properly perform the service as requested.
- 7. This application for permanent approval of the transfer of CPCN PUC No. 150 & I is in the public interest.

## II. ORDER

## A. The Commission Orders That:

- 1. The hearing set for January 18, 2005 is vacated.
- 2. This application was deemed complete on December 21, 2004 within the meaning of § 40-6-109.5, C.R.S.
- 3. The application filed by Boulder Yellow Cab for approval to transfer CPCN PUC No. 150 & I, subject to encumbrances, if any, against the authority, to Colorado Cab Company is granted.
- 4. Colorado Cab Company shall operate in accordance with all applicable Commission rules and regulations.
- 5. Approval of the transfer of Certificate of Public Convenience and Necessity PUC No. 150 & I is conditioned on the prior filing by Boulder Yellow Cab of delinquent reports, if any, covering operations under the certificate up to the consummation of the transfer.

- 6. Colorado Cab Company shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Colorado Cab Company shall also adopt the tariff of Boulder Yellow Cab which shall become that of Colorado Cab Company until changed in accordance with the public utilities law. Colorado Cab Company shall pay the appropriate vehicle identification fee. Boulder Yellow Cab shall file a terminating annual report from the first of January to the date of this Order. An acceptance of transfer signed by both Boulder Yellow Cab and Colorado Cab Company shall be filed with the Commission. Colorado Cab Company may not begin operations until these requirements have been met and it has received notice in writing from the Commission stating that it is in compliance and may begin service.
- 7. If Boulder Yellow Cab and Colorado Cab Company do not comply with the requirements of this Order within 60 days of its effective date, then the approval to transfer CPCN PUC No. 150 & I shall be void. For good cause shown, the Commission may grant additional time for compliance if the request for additional time is filed within the 60 days.
- 8. The 20-day time-period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, re-argument, or reconsideration shall begin on the first day after the Commission mails or serves this Order.

- 9. This Order is effective on its Mailed Date.
