**DECISION GRANTING JOINT MOTION FOR
APPROVAL OF AMENDMENT TO THE
INTERCONNECTION AGREEMENT**

I. BY THE COMMISSION

A. Statement

1. This matter comes before the Commission on the joint motion of Qwest Corporation, formerly known as U S WEST Communications, Inc. (Qwest), and XO Colorado, LLC, formerly known as Nextlink Colorado, LLC (XO) for approval of an amendment to their Interconnection Agreement (Agreement). The Agreement was initially approved in Decision No. C98-259, issued March 12, 1998.

2. The Parties filed this negotiated amendment on November 10, 2004. The Parties have decided to amend the Agreement to add rates, terms, and conditions for DC Power Measuring. Under the terms of 47 U.S.C. § 252(i) of the Telecommunications Act of 1996, XO may at some future date opt into the terms and conditions of Commission approved and currently effective agreements:

[a] local exchange carrier shall make available any interconnection, service, or network element provided under an agreement approved under this section to which it is a party to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement.

3. Section 47 U.S.C. § 251 *et seq.* of the Act requires that the Commission review and approve or reject interconnection agreements involving incumbent local exchange carriers like Qwest. To comply with the Act, rates in negotiated agreements must be just and reasonable, nondiscriminatory, and based on the cost of providing the interconnection or network element. 47 U.S.C. § 252(e). In reviewing agreements (or portions thereof) the Commission, generally, is guided by 47 U.S.C. § 252(e)(2), requiring that interconnection agreements not discriminate against non-parties and be consistent with the public interest, convenience, and necessity.

4. There are no rate changes associated with this amendment because rates will be based upon the amount of power consumed by XO. We therefore find it consistent with the directives of the Act, and our own interconnection agreement rules to approve the present amended terms and conditions subject to our own rules and general ratemaking proceedings.

II. ORDER

A. The Commission Orders That:

1. The joint motion of Qwest Corporation and XO Colorado, LLC to amend their Interconnection Agreement is granted.

2. This Order is effective upon its Mailed Date.
