## I. STATEMENT

- 1. On March 1, 2004, Staff of the Colorado Public Utilities Commission (Staff) filed a Motion for Presentation of Testimony of Staff's witness Donna Fink, and for partial waiver of Colorado Rules of Civil Procedure (C.R.C.P.) Rule 43(i).
- 2. Staff states that it intends to call an essential witness, Donna Fink, an employee of American and Foreign Insurance Company, located in Charlotte, North Carolina
- 3. Staff also requests a partial waiver of C.R.C.P. Rule 43(i) which requires that requests for testimony by telephone shall be made by motion at least 21 days prior to the hearing. Staff requests a waiver of the 21-day requirement.
