INTERIM ORDER OF ADMINISTRATIVE LAW JUDGE DALE E. ISLEY GRANTING MOTION TO CONSOLIDATE

I. <u>STATEMENT</u>

- 1. On June 14, 2004, the Staff of the Colorado Public Utilities Commission filed a Motion to Consolidate Docket No. 04G-061EC with Docket No. 04G-194EC (Motion to Consolidate) and for Shortened Response Time (Motion to Shorten) in the captioned proceedings.
- 2. On June 16, 2004, the Motion to Shorten was granted, in part. *See*, Decision No. R04-0657-I. That decision required that any desired responses to the Motion to Consolidate be filed on or before June 21, 2004. A review of the Commission's files in these matters reveals that the Respondent, Lawrence Torrez, doing business as Absolutely Devine Limousine (Torrez), did not respond to the Motion to Consolidate.

3. Rule 79(a) of the Commission's Rules of Practice and Procedure, 4 Code of

Colorado Regulations 723-1-79(a), authorizes the Commission to consolidate proceedings when

the issues are substantially similar and the rights of the parties will not be prejudiced.

4. Here, both proceedings involve the same parties and virtually identical issues.

Civil Penalty Assessment Notice (CPAN) No. 28402 issued in Docket No. 04G-061EC charges

Torrez with violating §§ 40-16-103 and 40-16-104, C.R.S., as does CPAN No. 28573 issued in

Docket No. 04G-194EC. There is no reason to believe that consolidating these proceedings for

hearing purposes will prejudice any party. Indeed, consolidation will promote judicial economy

and more efficient use of resources by all concerned.

5. For the foregoing reasons, the Motion to Consolidate will be granted. Both

proceedings will be heard on July 1, 2004, commencing at 1:00 p.m., the hearing date and time

currently scheduled in connection with Docket No. 04G-061EC.
