I. **STATEMENT**

> 1. On April 13, 2004, the Public Utilities Commission issued the Notice of Proposed

Rulemaking which commenced this docket. See Decision No. C04-0375. Appended to that

Order as Attachments A and B were proposed rules showing the changes from the rules as

proposed in Dockets No. 03R-519E and No. 03R-520G. The rules proposed in the instant docket

cover electric master meter operators and gas master meter operators; this Order addresses only

the gas master meter operators.

2. Decision No. C04-0375 established initial hearing dates of July 19 and 20, 2004,

for the gas master meter operator rules and invited interested persons to participate in the

rulemaking by submission of written comments and/or by presentation of oral comments. The

Order also "direct[ed] the [undersigned Administrative Law Judge (ALJ)] to include the

... proposed [master meter operator rule] changes as part of the ongoing gas and electric

rulemakings." *Id.* at ¶ I.6.

3. At the hearings held on July 19 and 20, 2004, the ALJ announced that the next

4. On August 3, 2004, the ALJ granted a motion to schedule additional hearing days

in Docket No. 03R-520G (the gas rulemaking). As a result, and to comply with the Commission

directive that the gas master meter operator rules and the gas rulemaking go forward together, it

is necessary to schedule two additional days of hearing in the instant proceeding. Those

additional days are October 18 and 19, 2004.
