I. <u>STATEMENT</u>

1. On May 19, 2004, Qwest Corporation (Qwest or Applicant) filed an Application for Approval of its Revised Exchange Area Map in the Denver Metro Exchange Aurora Zone and Declaration of its Intent to Serve Within the Territory of Eastern Slope Rural Telephone Association, Inc. (Application). The Application commenced this docket. Qwest subsequently filed an Amended Application.

2. The Commission gave public notice of the Application. *See* Notice of Application Filed, dated May 21, 2004.

3. Eastern Slope Rural Telephone Association, Inc., and Staff of the Commission are intervenors. Each opposes the Application.

4. Front Range Airport Authority (FRAA) is also a party. FRAA supports the Application.

5. A prehearing conference was held on July 29, 2004. Following that prehearing conference, the undersigned Administrative Law Judge issued Decision No. R04-0876-I which established a procedural schedule¹ and scheduled hearing dates of October 28 and 29, 2004, in this proceeding.

6. On August 3, 2004, TransPort: A Shuck Corporation Development (TransPort) filed out of time a Petition to Intervene (Petition). No certificate of service was filed with the Petition so the file in this matter does not reflect service of the Petition on the parties in this docket. Thus, a copy of the Petition is appended to this Order as Attachment A.

9. The date for filing testimony and exhibits in support of the Application is fast approaching. Therefore, by this Order the time for filing a response to the Petition is shortened to and including August 12, 2004.

II. ORDER

A. It Is Ordered That:

1. The time for filing a response to the Petition to Intervene filed by TransPort: A Shuck Corporation Development is shortened to and including August 12, 2004.

2. This Order is effective immediately.
