

Transportation of

passengers and their baggage, in scheduled service

- (1) Between the Aurora Mall, 14200 East Alameda Avenue, Aurora, Colorado, on the one hand, and the Colorado Convention Center, 700 14th Street, Denver, Colorado, on the other hand, with service to all intermediate points on a route beginning at the Aurora Mall; then east on Alameda Avenue to its intersection with Sable Boulevard; then north on Sable Boulevard to its intersection with 6th Avenue; then east on 6th Avenue to its intersection with Chambers Road; then north on Chambers Road to its intersection with Colfax Avenue; then west on Colfax Avenue to its intersection with 15th Street; then northwest on 15th Street to its intersection with Champa Street; then southwest on Champa Street to its intersection with 14th Street; then southeast on 14th Street to its intersection with Colfax Avenue; then east on Colfax Avenue to its intersection with Chambers Road; then south on Chambers Road to its intersection with 6th Avenue; then west on 6th Avenue to its intersection with Sable Boulevard; then south on Sable Boulevard to its intersection with Alameda Avenue; then east on Alameda Avenue to the point of beginning.
- (2) Beginning at the intersection of Havana Street and Colfax Avenue, thence south on Havana Street to its intersection with Parker Road, thence south on Parker Road to its intersection with Peoria Avenue, then returning over the same route to the point of beginning.
- (3) Beginning at the intersection of 60th Avenue and Dahlia Street, thence east on 60th Avenue to its intersection with Holly Street, thence south on Holly Street to its intersection with 56th Avenue, thence west on 56th Avenue to its intersection with Colorado State Highway 2, thence south on Colorado State Highway 2 to its intersection with Colorado Boulevard, thence south on Colorado Boulevard to its intersection with Evans Avenue, then returning over the same route to the point of beginning.
- (4) Beginning at the intersection of 52nd Avenue and Peoria Street, thence south on Peoria Street to its intersection with Parker Road, thence south on Parker Road to Nine Mile Park-N-Ride, then returning over the same route to the point of beginning.
- (5) Beginning at the intersection of 20th Street and Broadway, thence south on Broadway to its intersection with Bellevue Avenue, then returning over the same route to the point of beginning.
- (6) Beginning at the intersection of Broadway and Colfax Avenue, thence west on Colfax Avenue to its intersection with Federal Boulevard, thence south on Federal Boulevard to its intersection with Evans Avenue, then returning over the same route to the point of beginning. And

- (7) With authority for each passenger traveling on any of the routes named in Item Numbers (1), (2), (3), (4), (5), and (6) to transfer to any of the other routes at the intersections of Colfax Avenue and Peoria Street, Havana Street, Colorado Boulevard, Broadway, and Federal Boulevard.

RESTRICTIONS: This authority is restricted as follows:

This authority is restricted to the use of vehicles with a seating capacity of 15 to 32 passengers, including the driver.
