# INTERIM ORDER OF ADMINISTRATIVE LAW JUDGE WILLIAM J. FRITZEL ACCEPTING RESTRICTIVE AMENDMENT

### I. STATEMENT

- 1. On August 26, 2004, MKBS, LLC, doing business as Metro Taxi, Inc. (Metro Taxi), and Applicant Mobility Express Transportation System, Inc., filed a Stipulated Motion for Adoption of Restrictive Amendment to Application and Conditional Withdrawal of Intervention.
- 2. By the motion, Applicant moves to restrictively amend its application so that the only authority sought reads as follows:

Transportation of

passengers and their baggage in call-and-demand limousine service,

between the facilities of Denver Health at 777 Bannock Street, Denver, Colorado, and all points in the City and County of Denver, Colorado.

## **RESTRICTIONS:**

- I. The application is restricted against providing service to or from Denver International Airport;
- II. The application is restricted to providing transportation services only for passengers who are clients of Denver Health and to transportation that is paid by Denver Health or Medicaid.

- 3. Metro Taxi states in the motion that if the proposed restrictive amendment is accepted, it will withdraw its intervention.
  - 4. The proposed restrictive amendment is found to be acceptable.

# II. ORDER

### A. It Is Ordered That:

- 1. The motion of Applicant, Mobility Express Transportation System, Inc., to restrictively amend its application is accepted.
- 2. The full and complete authority sought in this application after acceptance of the restrictive amendment reads as follows:

Transportation of

passengers and their baggage in call-and-demand limousine service,

between the facilities of Denver Health at 777 Bannock Street, Denver, Colorado, and all points in the City and County of Denver, Colorado.

# **RESTRICTIONS**:

- I. The application is restricted against providing service to or from Denver International Airport;
- II. The application is restricted to providing transportation services only for passengers who are clients of Denver Health and to transportation that is paid by Denver Health or Medicaid.
- 3. This Order is effective immediately.
