I. <u>STATEMENT</u>

1. On May 22, 2004, Civil Penalty Assessment Notice (CPAN) No. 28427 was served on Kuboske's San Juan Scenic Jeep Tours, Inc., also known as/formerly known as San Juan Scenic Jeep Tours, also known as/formerly known as Kuboske's, also known as/formerly known as San Juan Scenic Jeep Tours, Inc. (Respondent).

2. The Commission scheduled a hearing in this matter for August 31, 2004.

3. On August 30, 2004, Respondent orally requested by telephone call to continue the hearing since Respondent could not appear at the scheduled hearing for the reason that a medical emergency in the family prevented Respondent from appearing at the scheduled hearing.

II. ORDER

A. It Is Ordered That:

1. The request of Respondent Kuboske's San Juan Scenic Jeep Tours, Inc., also known as/formerly known as San Juan Scenic Jeep Tours, also known as/formerly known as Kuboske's, also known as/formerly known as San Juan Scenic Jeep Tours, Inc., to continue the hearing is granted.
