INTERIM ORDER OF ADMINISTRATIVE LAW JUDGE DALE E. ISLEY GRANTING MOTION FOR EXTENSION, IN PART

I. STATEMENT

1. On December 13, 2004, Respondents, Ron and Shelley Vigil, doing business as A-Abcott Limousine (A-Abcott), filed a Motion for Extension (Motion) in the captioned proceeding. The Motion seeks an extension of time to file exceptions to Recommended Decision No. R04-1411, mailed November 30, 2004. Exceptions to Recommended Decision No. R04-1411 are currently due on or before December 20, 2004.

2. The Motion requests that A-Abcott be allowed to file its exceptions on the twentieth day after the hearing transcript is filed with the Commission. As grounds for the

requested extension, A-Abcott states that a review of the hearing transcript is essential to the preparation of its exceptions.

- 3. On December 15, 2004, Complainant, Staff of the Public Utilities Commission of the State of Colorado (Staff) filed its Response to the Motion. Staff does not oppose the relief requested therein so long as any extended deadline applies to both parties and a specific deadline is established for filing exceptions.
- 4. It appears that A-Abcott requested preparation of the hearing transcript on December 7, 2004. Informal consultation with the responsible court reporters reveals that the subject transcript cannot be prepared and filed with the Commission until December 22, 2004.
- 5. Rule 92 of the Commission's Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1-92, authorizes the Commission to extend the time for filing exceptions to recommended decisions. The requested extension is warranted in light of the fact that the hearing transcript will not be available until after the current deadline for filing exceptions expires.
- 6. Accordingly, the Motion will be granted, in part. Any desired exceptions to Decision No. R04-1411 shall be filed by A-Abcott and/or Staff on or before January 11, 2005.

II. ORDER

A. It Is Ordered That:

1. The Motion for Extension filed by Respondents, Ron and Shelley Vigil, doing business as A-Abcott Limousine, is granted, in part.
