**I. STATEMENT**

1. By Decision No. R13-0487-I (Decision) issued April 26, 2013, this matter was scheduled for a Prehearing Conference for May 9, 2013 at 2:00 p.m. Notice of the Decision was provided to SS Transportation, LLC (Applicant) on February 25, 2013, at the address Applicant included in his application. The same Decision ordered Applicant to either show cause why he may be represented by a non-attorney, or to have an attorney enter an appearance on its behalf. An attorney, Richard Gross, entered his appearance on behalf of Applicant on May 2, 2013.

2. The Administrative Law Judge (ALJ) waited until approximately 2:13 on May 9, 2013 for Applicant and his counsel to appear. Neither Applicant nor his attorney appeared.

3. However, Colorado Cab Company LLC and Colorado Springs Transportation, LLC appeared through counsel at the hearing.

4. The ALJ scheduled the matter for a hearing on the Application and set the below procedural deadlines. The ALJ will order the below schedule.

### **A. It Is Ordered That:**

1. **By 5:00 p.m. on June 5, 2013**, Applicant shall file and serve on all parties: its final witness lists, exhibit lists, and exhibits.

2. **By 5:00 p.m. on June 12, 2013**, Interveners shall file and serve on all parties: its final witness lists, exhibit lists, and exhibits.

3. Witness lists shall include a brief description of the anticipated testimony of each witness.

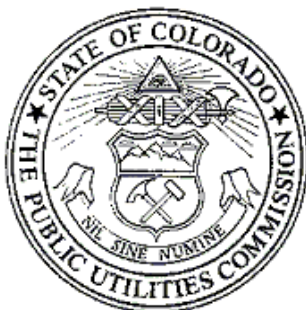
