Highway 6 and Colorado State Highway 58 in Golden, Colorado, thence east along Colorado State Highway 58 to its intersection with Ford Street; thence south along Ford Street to its intersection with 19th Street; thence west along 19th Street to its intersection with U. S. Highway 6; thence north along U. S. Highway 6 to the point of beginning, on the one hand, and 605 Johnson Road, Golden, Colorado, on the other hand; shall be a fixed rate of \$5.00 per passenger each way. Item 590 Call and Demand Limousine Service Only

Rates shall apply and be used only where no other call-and-demand limousine rates are named in this tariff.

- A. In vehicles of 1 to 7 passengers, \$0.50 per passenger; per mile; subject to the minimum rate of \$3.50 per mile, loaded.
- B. In vehicles of 8 to 15 passengers; \$0.50 per passenger; per mile; subject to the minimum rate of \$7.50 per mile, loaded.
- C. **N** - In vehicles of 16 to 25 passengers; \$0.50 per passenger; per mile; subject to the minimum rate of \$12.50 per mile, loaded. - **N**
