**I. BY THE COMMISSION**

**A. Statement**

1. On June 13, 2014, Public Service Company of Colorado (Public Service) filed a Joint Submission of Proposed Procedural Schedule and Joint Motion to Vacate Prehearing Conference (Joint Submission).

2. On June 16, 2014, Vote Solar filed a Motion for Errata Notice. Vote Solar states that Paragraph 19 of Decision No. C14-0616-I issued June 9, 2014, incorrectly omitted Vote Solar as a party.

3. Being duly advised in these matters, we adopt the procedural schedule and discovery procedures proposed in the Joint Submission, grant the motion to vacate the prehearing conference scheduled for June 19, 2014, and waive response time. We also grant the Motion for Errata Notice and waive response time.

**B. Joint Submission**

4. Pursuant to Decision No. C14-0616-I, Public Service consulted with all parties and developed a consensus procedural schedule as follows:

Applications Deemed Complete	Thursday, May 22, 2014
Supplemental Testimony	Friday, July 11, 2014
Answer Testimony	Friday, August 29, 2014
Rebuttal/Cross Answer Testimony	Friday, October 3, 2014
Hearings	November 3-5, 2014
Statements of Position	Wednesday, November 19, 2014
Commission Issue Decision by 210th Day	Thursday, December 18, 2014

5. The Joint Submission also presents the following discovery procedures:

The parties agreed that the Commission's normal discovery rules set forth [at] 4 CCR 723-1-1405 shall apply, with the following agreed modifications:

- 1) Discovery requests and Discovery responses shall be served on all parties, subject to restrictions that apply to the discovery of Confidential Information and Highly Confidential Information.
- 2) Discovery propounded on a day before a non-business day (week-ends and holidays) must be served on or before 3 PM in order for it to be considered served on that day.
- 3) Subject to the need to preserve confidentiality, all Discovery requests and responses may be served by email.

6. We find this proposed procedural schedule and discovery procedures are reasonable and therefore adopt them without modification.

7. The Joint Submission also seeks to vacate the prehearing conference scheduled for June 19, 2014. Since the Joint Submission states that all parties concur with the proposed procedural schedule and discovery procedures, we vacate the prehearing conference and waive response time.

**C. Motion for Errata Notice**

8. Vote Solar states that Decision No. C14-0616-I grants its intervention request in Proceeding No. 14A-0302E. However, Paragraph 19, which is a summary of all parties in the consolidated proceedings, does not include Vote Solar. The motion requests that the Commission issue an Errata Notice to correct paragraph 19 to include Vote Solar as a party, and waive response time.

9. We agree, grant the Motion for Errata Notice, and waive response time.

**II. ORDER**

**A. It Is Ordered That:**

1. The schedule as proposed in the Joint Submission of Proposed Procedural Schedule filed on June 13, 2014, by Public Service Company of Colorado is adopted, consistent with the above discussion.
