**I. BY THE COMMISSION**

**A. Statement, Findings, and Conclusions**

1. This matter comes before the Commission for consideration of a motion for an extension of time to file exceptions to Recommended Decision No. R14-1069 (Decision), filed by Staff of the Colorado Public Utilities Commission (Staff) on September 9, 2014.

2. Rule 1505(a), of the Rules of Practice and Procedure, 4 *Code of Colorado Regulations* 723-1, states that a recommended decision becomes the Commission's decision unless, within 20 days or such additional time as the Commission may allow, any party files exceptions to the recommended decision. This rule further states that a motion for an extension of time to file exceptions based upon the unavailability of a transcript shall show that the transcript request was filed within seven days of the mailed date of the recommended decision.

3. The Decision was mailed on September 4, 2014. Therefore, a request for a transcript was due on September 11, 2014; and, exceptions must be filed by September 24, 2014.

4. In support of the motion, Staff attached an email to the motion showing that a request for the transcript was timely made on September 8, 2014. Staff states that Staff was told the transcript would not be ready until the week of September 15, 2014. Staff requests that the Commission extend the time for filing exceptions to October 8, 2014 in order to provide Staff sufficient time to review the transcript and prepare its exceptions.

5. We find that good cause has been shown to grant the motion for extension of time to file exceptions through October 8, 2014.

## **II. ORDER**

### **A. The Commission Orders That:**

1. Consistent with the discussion above, the motion for an extension of time to file exceptions to Recommended Decision No. R14-1069, filed by Staff of the Colorado Public Utilities Commission on September 9, 2014, is granted.

2. Exceptions to Recommended Decision No. R14-1069 may be filed by and including October 8, 2014.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

4. This Decision is effective on its Mailed Date.
