**I. STATEMENT**

1. On November 12, 2013, Staff of the Colorado Public Utilities Commission (Staff) filed a Civil Penalty Assessment Notice (CPAN) with the Commission against Silver Lion Limousine LLC (Respondent).

2. On December 4, 2013, the Commission referred the matter to an administrative law judge to decide the merits of the CPAN.

3. By Interim Decision No. R13-1515-I, issued on December 9, 2013, a procedural schedule was set and an evidentiary hearing was scheduled. The procedural schedule required Staff to file and serve exhibit and witness lists and exhibits on or before 5:00 p.m. on January 13, 2014.

4. The procedural schedule also required the Respondent to make similar filings on or before January 20, 2014 at 5:00 p.m. and scheduled the evidentiary hearing for February 4, 2014.

5. On January 13, 2014, Staff filed their Motion for Extension of Time to File Witness and Exhibit Lists (Motion). As grounds, Staff states that due to the “press of business” Staff counsel has been unable to complete the task and requests a two-day extension, until January 15, 2014. Staff also states that the Respondent has been consulted and did not object to the requested relief.

6. Good cause having been found the Motion shall be granted. Staff shall be required to file and serve exhibit and witness lists and exhibits on or before 5:00 p.m. on January 15, 2014. The deadline for the Respondent to file and serve exhibit and witness lists and exhibits shall also be extended two days until January 22, 2014. The evidentiary hearing shall remain scheduled for February 4, 2014 at 9:00 a.m.

7. Although not requested, response time to the Motion shall be waived.

## II. ORDER

### A. **It Is Ordered That:**

1. Commission Staff’s Motion for Extension of Time to File Witness and Exhibit Lists is granted.

2. Commission Staff shall file and serve exhibit and witness lists and exhibits **on or before 5:00 p.m. on January 15, 2014.**

3. Silver Lion Limousine LLC shall file and serve exhibit and witness lists and exhibits **on or before 5:00 p.m. on January 22, 2014.**

4. Response time to the Motion for Extension of Time to File Witness and Exhibit Lists is waived.

5. This Decision is effective immediately.
