**RECOMMENDED DECISION OF
ADMINISTRATIVE LAW JUDGE
MELODY MIRBABA
REVOKING AUTHORITIES AND PERMITS
PURSUANT TO COMPLAINT**

I. STATEMENT, FINDINGS, AND CONCLUSIONS

1. The cases listed on the attached Appendix A (Hearing Exhibit 1) were instituted by “Order of Summary Suspension and Complaint and Notice of Hearing,” (Complaint), issued by the Commission Director and served upon the Respondents on December 20, 2013 (Hearing Exhibit 2) by United States mail, at the most recent addresses on file with the Commission for the Respondents. The Complaint provided notice of the date, time, and location of the hearing regarding the Complaint. At the designated date, time, and location, January 14, 2014 at 12:00 p.m., the undersigned Administrative Law Judge called the cases for hearing in a Commission Hearing Room, at 1560 Broadway, Suite 250, Denver, Colorado.

2. Commission Staff member Vanessa Condra appeared through counsel and testified on behalf of the Staff of the Commission (Staff). Mr. Ron Simpson appeared and testified on behalf of Respondent Kid Gloves LLC (Kid Gloves) No other Respondent appeared. No Respondent has shown cause for its failure to appear.

3. This Decision does not address the Complaint against Kid Gloves. The ALJ has continued the hearing on the Complaint against Kid Gloves and will issue a separate recommended decision regarding Kid Gloves. Decision No. R14-0053-I.

4. Hearing Exhibits 1, 2, 3, and 4 were identified, offered, and admitted into evidence during the hearing.

5. Pursuant to § 40-10.1-107, C.R.S., and Rule 6007 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* (CCR) 723-6, every motor carrier must keep and maintain evidence of financial responsibility in such sum, for such protection, and in such form as the Commission deems necessary to adequately safeguard the public interest.

6. In addition, § 42-20-202(2)(a), C.R.S., requires that motor carriers with a Commission permit to transport hazardous materials must maintain and file proof of liability insurance. At any time said insurance lapses, the Commission “shall” revoke the permit. *Id.*

7. Moreover, every towing carrier must obtain and keep in force at all times workers’ compensation coverage in accordance with the “Workers’ Compensation Act of Colorado” found in Articles 40 to 47 of Title 8, C.R.S. Rule 6007(a)(VI), of the Rules Regulating Transportation by Motor Vehicle, 4 CCR 723-6.

8. Section 40-10.1-112, C.R.S., and the Commission’s rules implementing that section, provide that, after hearing upon notice to the holder of any certificate or permit, and upon proof of violation, a Commission issued authority or permit may be suspended, revoked, altered, or amended if it is established to the satisfaction of the Commission that the holder of that authority or permit has violated any applicable statute, rule, regulation, or Commission decision. Rule 6008, 4 CCR 723-6; *see* Hearing Exhibit 2.

9. Complaints and Notices of Suspension and Hearing in compliance with Rule 6008(a)(II), 4 CCR 723-6, were served upon the Respondents listed on Hearing Exhibit 1, attached to this Recommended Decision as Appendix A, at the most recent addresses on file with the Commission. Hearing Exhibit 2. Service was proper.

10. At hearing, Staff established by a preponderance of the evidence that the Commission's records do not show a currently effective level of financial responsibility, including hazardous materials transportation carriers' liability insurance and worker's compensation coverage, in such form and in such manner as required for the Respondents as stated in Appendix A. §§ 40-10.1-107, C.R.S.; 42-20-202(2)(a), C.R.S.; Articles 40 to 47 of Title 8, C.R.S.; Rule 6007, 4 CCR 723-6.

11. The Commission's only means of performing the important health and safety function of guaranteeing that persons who hold an authority or permit from the Commission have current, effective insurance, including hazardous materials transportation carriers' liability insurance and worker's compensation coverage, is to have documentation of that fact furnished in a uniform format to the Commission. The holder of the authority is responsible for providing that documentation to the Commission. §§ 40-10.1-107 and 42-20-202(2)(a), C.R.S.; Articles 40 to 47 of Title 8, C.R.S.; Rules 6007(f), (g), and (i), 4 CCR 723-6.

12. Except for Kid Gloves, because the Respondents listed in Appendix A have failed to keep currently effective proof of financial responsibility on file with the Commission, including hazardous materials transportation carriers' liability insurance, and worker's compensation insurance, and none have shown good cause for such failure, the authorities and permits listed in Appendix A should be revoked.

13. The ALJ does not recommend that Respondent Kid Gloves' authority or permit be revoked at this time. This proceeding shall remain open until the ALJ issues a decision regarding the Complaint against Kid Gloves.

14. Pursuant to § 40-6-109, C.R.S., the Administrative Law Judge transmits to the Commission the record of this proceeding, this recommended decision containing findings of fact and conclusions thereon, and a recommended order. However, the proceeding will remain open so that the ALJ may address the Complaint against Respondent Kid Gloves. Thus, the record in this proceeding will be bifurcated. When the ALJ issues a separate recommended decision regarding Kid Gloves, the ALJ will transmit the bifurcated record, which will include any additions. Any such additions to the bifurcated record do not relate to or otherwise impact this Decision or the Respondents whose authorities or permits are impacted by this Decision.

15. Pursuant to § 40-6-109, C.R.S., it is recommended that the Commission enter the following order.

II. ORDER

A. The Commission Orders That:

1. Consistent with the discussion above, except for Respondent Kid Gloves LLC (Kid Gloves), the Respondents' authorities or permits listed in Appendix A attached hereto are revoked as of the effective date of this Decision.

2. Ordering Paragraph No. 1 shall be void and the case dismissed as to any affected Respondent who:

- (a) files the required Certificate of Insurance with the Commission before the effective date of this Recommended Decision; or
- (b) files a notice with the Commission before the effective date of this Recommended Decision that workers' compensation coverage is no longer

required; the notice shall include a factual basis for the conclusion that workers' compensation coverage is not required.

3. This proceeding shall remain open so that the administrative law judge may address the Complaint against Kid Gloves by separate decision. For the same reason, the record shall be bifurcated.

4. This Recommended Decision shall be effective on the day it becomes the Decision of the Commission, if that is the case, and is entered as of the date above.

5. As provided by § 40-6-109, C.R.S., copies of this Recommended Decision shall be served upon the parties, who may file exceptions to it.

a) If no exceptions are filed within 20 days after service or within any extended period of time authorized, or unless the decision is stayed by the Commission upon its own motion, the recommended decision shall become the decision of the Commission and subject to the provisions of § 40-6-114, C.R.S.

b) If a party seeks to amend, modify, annul, or reverse basic findings of fact in its exceptions, that party must request and pay for a transcript to be filed, or the parties may stipulate to portions of the transcript according to the procedure stated in § 40-6-113, C.R.S. If no transcript or stipulation is filed, the Commission is bound by the facts set out by the administrative law judge and the parties cannot challenge these facts. This will limit what the Commission can review if exceptions are filed.

6. If exceptions to this Decision are filed, they shall not exceed 30 pages in length, unless the Commission for good cause shown permits this limit to be exceeded.
