MODIFYING PROCEDURAL SCHEDULE AND
PARTIALLY VACATING HEARING**

I. STATEMENT

1. By Decision No. R13-1022-I, issued August 19, 2013, a procedural schedule was adopted to govern this proceeding. Several subsequent modifications have been ordered.

2. On January 15, 2014, the Joint Motion to Modify Procedural Schedule and for Waiver of Response Time was filed by Atmos Energy Corporation, Trial Staff of the Public Utilities Commission, Energy Outreach Colorado, and the Colorado Office of Consumer Counsel. The parties have reached a comprehensive unopposed settlement agreement to resolve their differences in this proceeding and request modification to the procedural schedule consistent therewith.

3. The unopposed proposed procedural schedule is reasonable and will be adopted as ordered below.

4. The simultaneously filed Joint Motion to Approve Stipulation and Settlement Agreement will be ruled upon by separate decision.

5. Parties are reminded that previously-ordered procedures regarding hearing exhibits continue to apply in this proceeding.

II. ORDER

A. It Is Ordered That:

1. The Unopposed Motion to Modify Procedural Schedule filed by Atmos Energy Corporation, Trial Staff of the Public Utilities Commission, Energy Outreach Colorado, and the Colorado Office of Consumer Counsel on January 15, 2014, is granted.

2. A hearing in this matter is currently scheduled to commence in this matter on February 12, 2014 and continue through February 14, 2014. The continued hearing dates of February 13 and 14, 2014 will be vacated and the matter will be heard on February 12, 2014.

3. A hearing in this matter shall be conducted at the following date, time, and place:

6. After all direct testimony is filed, the undersigned will further consider whether the scheduled hearing may be vacated.
