RESCHEDULING HEARING AND DEADLINES**

I. STATEMENT

1. On March 21, 2014, Staff of the Colorado Public Utilities Commission (Staff) filed the Unopposed Motion to Alter Both the Hearing Date and ZippyTech's Deadline to Answer or Satisfy the Complaint. Following service of the Complaint, ZippyTech Incorporated (ZippyTech) initiated communications with Staff indicating a desire to resolve the matter without further litigation. Staff welcomes ZippyTech's approach to the matter and is encouraged by it. Based thereupon, delays are sought to explore resolution.

2. ZippyTech company representatives do not oppose the relief requested in the motion.

3. Staff requests that:

a) the hearing in this matter be re-set for June 3, 2014;

- b) ZippyTech's deadline to satisfy the Complaint or file its answer be extended to April 17, 2014; and
- c) response time to the unopposed request be waived.
- 4. The request being unopposed, it is appropriate that response time be waived.
- 5. Good cause shown for the unopposed request, the motion will be granted.

II. ORDER

A. It Is Ordered That:

1. Response time to the Unopposed Motion to Alter Both the Hearing Date and ZippyTech's Deadline to Answer or Satisfy the Complaint filed by Staff of the Colorado Public Utilities Commission filed on March 21, 2014, is waived and the request is granted.

2. The hearing scheduled to commence in this matter on April 21, 2014, is vacated.

3. A hearing in this proceeding is scheduled as follows:
